
Letter of Approval for A Power Generation Project Using Waste Heat from the Coke Dry Quenching (CDQ) Equipment of Antai Group As a Clean Development Mechanism Project by National Development and Reform Commission of the People's Republic of China

The Chinese Government approves A Power Generation Project Using Waste Heat from the Coke Dry Quenching (CDQ) Equipment of Antai Group as a Clean Development Mechanism project, with the following remarks:

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. A Power Generation Project Using Waste Heat from the Coke Dry Quenching (CDQ) Equipment of Antai Group complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Shanxi Antai Group Holding Co., Ltd is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Shanxi Antai Group Holding Co., Ltd is permitted to transfer to Japan Carbon Finance, Ltd that is authorized by the Government of Japan no more than 360,000 tCO₂e in total Certified Emission Reductions (CERs).
