

3. Taiyuan Yingxian Coking & Chemicals Co., Ltd is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Taiyuan Yingxian Coking & Chemicals Co., Ltd is permitted to transfer to Trading Emissions PLC that is authorized by the Government of the United Kingdom no more than 700,000 tCO₂e in total Certified Emission Reductions (CERs).
