

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. Nanzhahe Cascade Hydropower Project complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Yongzhou Zhongxin Hydropower Development Co., Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Yongzhou Zhongxin Hydropower Development Co., Ltd. is permitted to transfer to Standard Bank Plc. that is authorized by the Government of United Kingdom no more than 200,000 tCO<sub>2</sub>e in total Certified Emission Reductions (CERs).
