

3. Dongkou Zhexiang Hydroelectric Co., Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Dongkou Zhexiang Hydroelectric Co., Ltd. is permitted to transfer to Wienerberger AG that is authorized by the Government of the United Kingdom no more than 230,000 tCO<sub>2</sub>e in total Certified Emission Reductions (CERs).
