一、该项目符合《清洁发展机制项目运行管理办法》规定的许可条件，符合我国实现可持续发展的战略目标，同意作为清洁发展

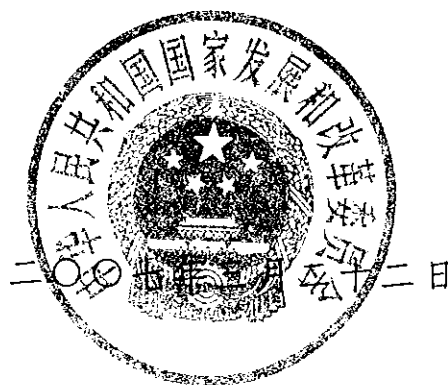



1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. The Animal Manure Management System GHG Mitigation Project, Shandong Minhe Livestock Co. Ltd., Penglai, Shandong Province, P.R. of China, complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Shandong Minhe Livestock Co., Ltd is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Shandong Minhe Livestock Co., Ltd is permitted to transfer to the International Bank for Reconstruction and Development as trustee of Community Development Carbon Fund that is authorized by the Government of the Netherlands no more than 600,000 tCO₂e in total Certified Emission Reductions (CERs).
