

Letter of Approval

The Government of Sweden, acting through the Sweden's Designated National Authority, the Swedish Energy Agency, hereby declares that:

- (i) Sweden ratified the Kyoto Protocol on 31 May 2002;
- (ii) Sweden participates voluntarily in the Clean Development Mechanism;
- (iii) the Government of Sweden hereby approves and authorizes the voluntary participation of the *International Bank for Reconstruction and Development* as Trustee (the "Trustee") and managing company of the Prototype Carbon Fund (PCF) in the below enumerated project activities ("Projects");
- (iv) as a Party directly involved in the projects, the Government of Sweden authorizes the participation of the *Swedish Energy Agency* as a Project Participant in the below-stated project activities (the "Projects"), and wishes to receive CERs in the national registry account SE-121-920-0.

PREAMBLE

Whereas:

- A. Sweden has ratified the Kyoto Protocol to the United Nations Framework Convention on Climate Change on May 31, 2002.
- B. The Swedish Energy Agency has been appointed Designated National Authority for the Clean Development Mechanism.
- C. Generadora de Occidente Ltda. ("Project Entity") owns and is implementing the El Canadá Hydroelectric Project ("The Project") which aims at fossil fuel by installation of run-of-river hydropower in Guatemala.
- D. The Project Entity and the International Bank for Reconstruction and Development as Trustee of the Prototype Carbon Fund ("The Purchaser") have agreed to the sale and purchase of certified emission reductions generated by the Project.


NOW THEREFORE the undersigned as legal and authorized representative of the Government of Sweden declares that:

DECLARATION:

1. Sweden *approves* the Project as Clean Development Mechanism (CDM) project in accordance with Article 12 of the Kyoto Protocol and the relevant rules, decisions, guidelines, modalities, and procedures thereunder and confirms that the participation in the Project is voluntary.
2. Sweden *authorizes* the Purchaser to participate in the Project activity in accordance with the Kyoto Protocol, the Marrakech Accords and the relevant rules, decisions, guidelines, modalities, and procedures thereunder.
3. Sweden *confirms* that the public funding provided by Sweden, at the disposal of the IBRD, used for the purchase of Certified Emission Reductions from the Project does not result in the diversion of Swedish official development assistance.
4. Sweden *recognises* that the International Bank for Reconstruction and Development, as Trustee for the Prototype Carbon Fund is the focal point for the Project Activity with respect to all communications with the Executive Board and the United Nations Framework Convention on Climate Change.
