
**Letter of Approval for Jilin Province Zhenlai Heiyupao 49.5MW The First Phase

The Chinese Government approves Jilin Province Zhenlai Heiyupao 49.5MW The First Phase Wind Farm Project as a Clean Development Mechanism project, with the following remarks:

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. Jilin Province Zhenlai Heiyupao 49.5MW The First Phase Wind Farm Project complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Jilin Taihe Windpower Development Co., Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Jilin Taihe Windpower Development Co., Ltd. is permitted to transfer to Carbon Asset Management Sweden AB which is authorized by the Government of the Sweden no more than 430,000tCO₂e in total Certified Emission Reductions (CERs).
