
Letter of Approval for Hubei Eco-Farming Biogas Project Phase I As a Clean Development Mechanism Project by National Development and Reform Commission of the People's Republic of China

The Chinese Government approves Hubei Eco-Farming Biogas Project Phase I as a Clean Development Mechanism project, with the following remarks:

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. Hubei Eco-Farming Biogas Project Phase I complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Hubei Qingjiang Zhongye Company Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Hubei Qingjiang Zhongye Company Ltd. is permitted to transfer to the International Bank for Reconstruction and Development (IBRD) as trustee of Community which is authorized by the Government of the Netherlands no more than 290,000 tCO₂e in total Certified Emission Reductions (CERs).
