
### Letter of Approval for Guangrun Hydropower Project in Hubei Province As a Clean Development Mechanism Project by National Development and Reform Commission of the People's Republic of China

The Chinese Government approves the Guangrun Hydropower Project in Hubei Province as a Clean Development Mechanism project, with the following remarks:

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. The Guangrun Hydropower Project in Hubei Province complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Hubei Guangrun Hydropower Development Company Ltd is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Hubei Guangrun Hydropower Development Company Ltd is permitted to transfer to the International Bank for Reconstruction and Development as trustee of Community Development Carbon Fund no more than 500,000 tCO<sub>2</sub>e in total Certified Emission Reductions (CERs).
