
Letter of Approval for Bailongjiang Dalijie Hydropower Station As a Clean Development Mechanism Project by National Development and Reform Commission of the People's Republic of China

The Chinese Government approves Bailongjiang Dalijie Hydropower Station as a Clean Development Mechanism project, with the following remarks:

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. Bailongjiang Dalijie Hydropower Station complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. GEPIC Darong Electric Power Company Ltd is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. GEPIC Darong Electric Power Company Ltd is permitted to transfer to N.v. Nuon Energy Trade & Wholesale which is authorized by the Government of the Netherlands no more than 540,000 tCO₂e in total Certified Emission Reductions (CERs).
