
Letter of Approval for Gansu Guazhou Ganhekou No.8 Wind Farm Project by National Development and Reform Commission of the People's Republic of China

The Chinese Government approves Gansu Guazhou Ganhekou No.8 Wind Farm Project as a Clean Development Mechanism project, with the following remarks:

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. Gansu Guazhou Ganhekou No.8 Wind Farm Project complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Gansu Guazhou Xiehe Wind Power Co., Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Gansu Guazhou Xiehe Wind Power Co., Ltd. is permitted to transfer to United Carbon Credits Limited which is authorized by the Government of the United Kingdom no more than 980,000tCO₂e in total Certified Emission Reductions (CERs).
