
### Letter of Approval for Qi'nan Hydro Power Project As a Clean Development Mechanism Project by National Development and Reform Commission of the People's Republic of China

The Chinese Government approves Qi'nan Hydro Power Project as a Clean Development Mechanism project, with the following remarks:

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. Qi'nan Hydro Power Project complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Yuzaikou Hydropower Co., Ltd is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Yuzaikou Hydropower Co., Ltd is permitted to transfer to Carbon Asset Management Sweden AB that is authorized by the Government of Sweden no more than 250,000 tCO<sub>2</sub>e in total Certified Emission Reductions (CERs).
