
### Letter of Approval for Liaoning Guoli Fuxin Wangsiyingzi Wind Power Project by National Development and Reform Commission of the People's Republic of China

The Chinese Government approves Liaoning Guoli Fuxin Wangsiyingzi Wind Power Project as a Clean Development Mechanism project, with the following remarks:

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. Liaoning Guoli Fuxin Wangsiyingzi Wind Power Project complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China (Modified), and assists China in achieving sustainable development.
3. Liaoning Guoli Renewable Energy Co. Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Liaoning Guoli Renewable Energy Co. Ltd. is permitted to transfer to Vitol S.A. which is authorized by the Government of Switzerland no more than 720,000tCO<sub>2</sub>e in total Certified Emission Reductions (CERs).
