
Letter of Approval for Inner Mongolia Wuchuan Yihemei Wind Farm 49.5MW Project by National Development and Reform Commission of the People's Republic of China

The Chinese Government approves Inner Mongolia Wuchuan Yihemei Wind Farm 49.5 MW Project as a Clean Development Mechanism project, with the following remarks:

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. Inner Mongolia Wuchuan Yihemei Wind Farm 49.5MW Project complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Wuchuan County Yihe Wind Power Generation Co., Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Wuchuan County Yihe Wind Power Generation Co., Ltd. is permitted to transfer to Carbon Resource Management S.A. which is authorized by the Government of the United Kingdom no more than 240,000tCO₂e in total Certified Emission Reductions (CERs).
