## SECTION A. Description of project activity

### A.1. General description of project activity

>>

The purpose of the project activity is to utilize renewable wind energy for generation of electricity. The project activity replaces anthropogenic emissions of greenhouse gases (GHGs) into the atmosphere by displacing the equivalent amount of electricity generation through the operation of existing fuel mix in the grid comprising mainly fossil fuel based power plants and future capacity expansions connected to the grid. In the absence of the project activity the equivalent amount of electricity would have been generated from the connected/ new power plants in the Southern grid, which are predominantly based on fossil fuels. Whereas the electricity generation from operation of Wind Energy Convertors (WEC's) is emission, free.

The project activity involves supply, erection, commissioning and operation of 63 machines of rated capacity 800 kW each. The machines are Enercon E-53 make. The WECs under the project activity were commissioned between 29/09/2010 and 11/07/2011. The expected operational lifetime of the project is for 20 years.

The project activity has been registered under CDM on 19 July 2011 and all the machines were under the Power Purchase Agreement with state utility for supply of electricity to the southern regional grid. However, during post registration phase (i.e. during Feb 2016), the ownership of 19 machines has been transferred to its subsidiary company "Vaayu Renewable Energy (Godavari) Private Limited (VREGPL)"<sup>2</sup>.

Further, the power purchase agreement for the 19 machines under VREGPL has been restructured and electricity is being supplied to JK Tyre & Industries Limited through two different third party sale agreements (as per TANGEDCO statements). As per the present arrangement, the electricity generated by these 19 machines is being pooled through Tamil Nadu state distribution & transmission network first (part of southern grid which is now integrated with Indian Grid) and then further supplied to JK Tyre & Industries Limited. However, the remaining 44 machines under the ownership of Vaayu (India) Power Corporation Private Limited (VIPCL) continue to supply electricity to the state grid as per the existing arrangements without any change.

Above changes in project design was approved by UNFCCC via PRC Request "PRC-4930-002", approved on 16/01/2019.

The total emission reductions achieved under this monitoring period from 01/01/2020 to 31/12/2020 (including first and last day) are 94,644 tCO<sub>2</sub>.

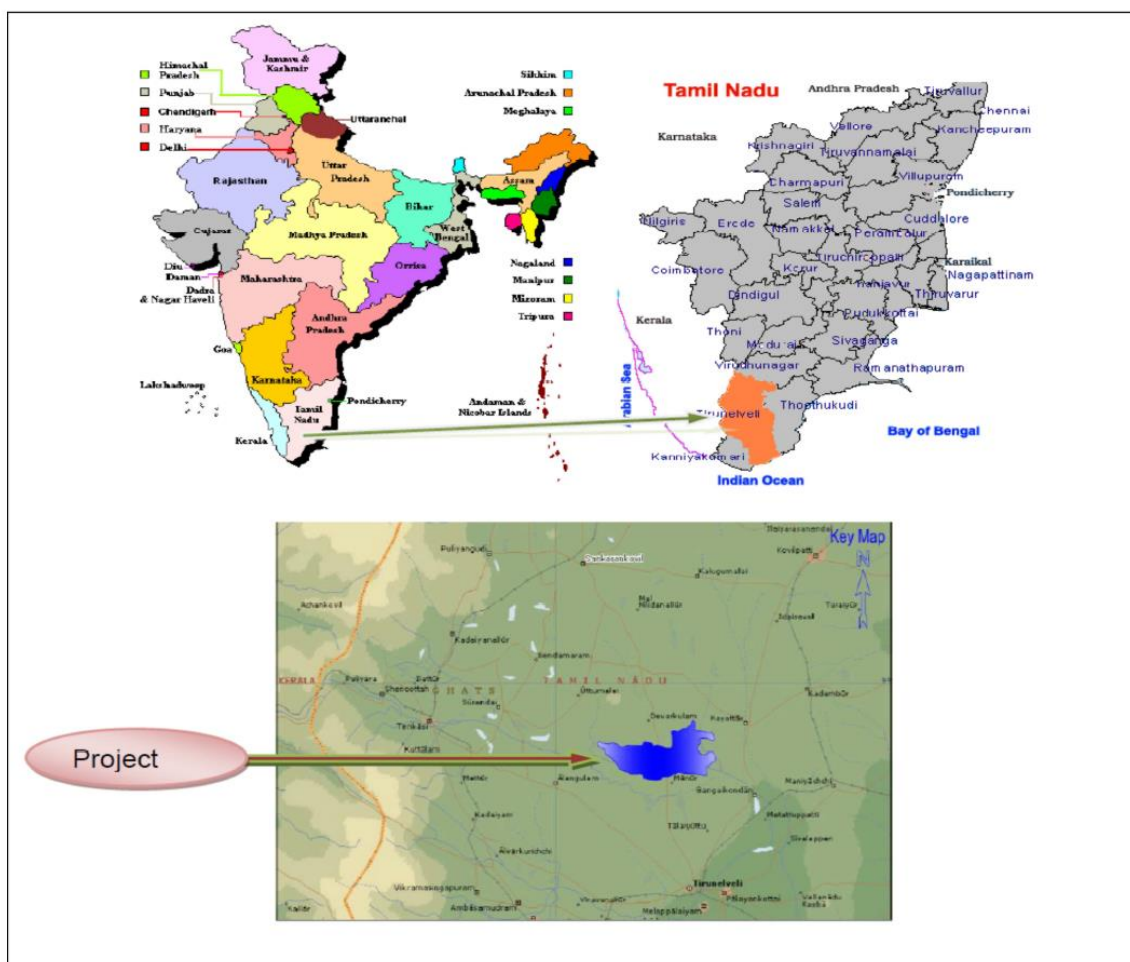

Tirunelveli railway station is about 25 kms away from the site. Nearest airport is at Tuticorin about 70 kms from the site. The length of the Crediting period of the project activity as per registered PDD is 10 years (Fixed). The crediting period start date is 19/07/2011 and length of crediting period is 10 years (from 19/07/2011 to 18/07/2021).

**SECTION B. Implementation of project activity****B.1. Description of implemented project activity**

&gt;&gt;

The project activity involves 63-wind energy converters (WECs) of Enercon make (800 kW E- 53) with internal electrical lines connecting the project activity with local evacuation facility. The WECs generates 3-phase power at 400 V, which is stepped up to 33 kV. The project activity can operate in the frequency range of 47.5–51.5 Hz and in the voltage range of 400 V ± 12.5%. The average life time of the WEC is around 20 years as per the industry standards. The salient features of the state-of-art-technology are:

During the last monitoring period, there is a permanent change in the project activity as out of the 63 registered WTGs, the ownership of 19 WTGs had been changed from “Vaayu (India) Power Corporation Pvt. Ltd.” to “Vaayu renewable energy Godavari Pvt. Ltd.” w.e.f. March 2016. Therefore, a request for post registration change is being submitted to UNFCCC along with this verification to address the change.

The changes have been approved by UNFCCC via a Post Registration Change (PRC) request; which was submitted via revised PDD (version 10, dated 03 Oct 2018) and got approved on 16/01/2019

**B.2.5. Permanent changes to the registered monitoring plan, or permanent deviation of monitoring from the applied methodologies, standardized baselines, or other methodological regulatory documents**

**Previous:**

1. PP requested for a permanent change in Monitoring plan as the frequency of energy meter calibration prescribed under registered monitoring plan has not been practiced by state utility. The scope of meter calibration is solely controlled and under the purview of state utility of Tamil Nadu and as per prevailing practice it does not adhere to the prescribed frequency of once in a year. Therefore, as per provision of CEA regulations 2006 issued by the Central Electricity Authority, Ministry of Power, Government of India Notification No. 502/70/CEA/DP&D dated 17/03/2006 and also as per the provision of section 4 paragraphs (iv) and (v) of the Power Purchase Agreement, PP has requested for a permanent change in the calibration frequency from annual to 'once in a five year'. This request was approved by UNFCCC on 08 Jun 2016<sup>3</sup>.

2. During the last monitoring period, a Post Registration Change (PRC) was made related to ownership change of 19 WTGs as described under the section A.1 and footnote reference 1. The PRC request was made via registered PDD version 10, dated 03/10/2018, which was approved by UNFCCC on 16/01/2019. This PRC includes some associated permanent changes into the registered monitoring plan and parameters. Such changes include representation of line diagram, source of data for monitoring parameters, cross checking mechanism, etc. These changes are included in the respective sections of the monitoring plan.

## SECTION C. Description of monitoring system

>>

Approved monitoring methodology ACM0002 Version 12.1.0, "Consolidated baseline monitoring methodology for grid-connected electricity generation from renewable sources", by CDM - Meth Panel is proposed to be used to monitor the emission reductions.

Wind World (India) Limited (WWIL) (formerly Enercon (India) Limited) is O&M contractor for the project activity. WWIL is responsible for the maintaining all the monitoring data on behalf of VIPCPL and VREGPL for their respective machines in respect of the project activity. WWIL has implemented the management structure for managing the monitored data.

This approved monitoring methodology requires monitoring of the following:

- Electricity generation from the project activity; and
- Operating margin emission factor and build margin emission factor of the grid, where ex post determination of grid emission factor has been chosen

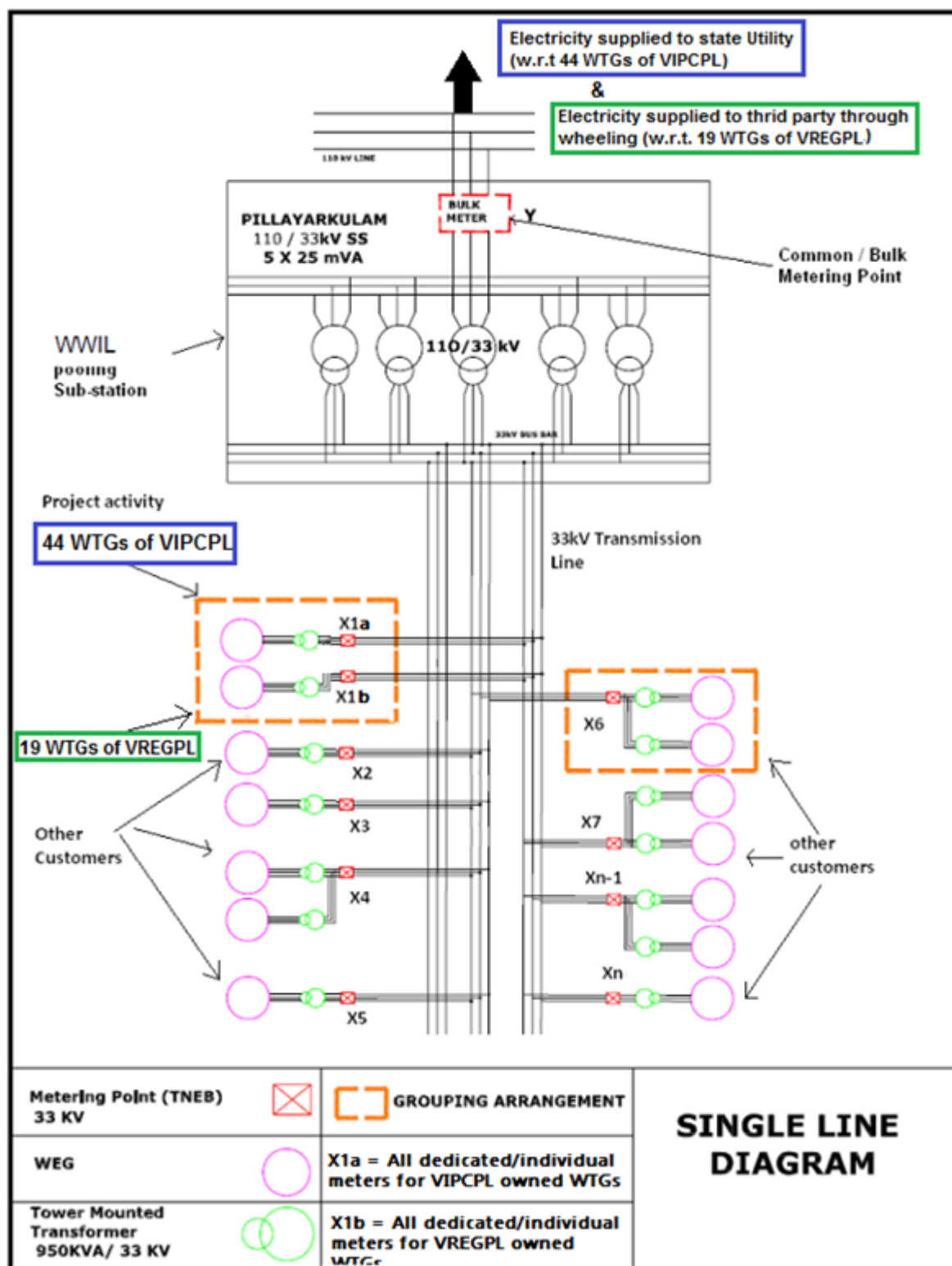
Since the baseline methodology is based on ex ante determination of the baseline, the monitoring of operating margin emission factor and build margin emission factor is not required. Further, wind based electricity generation is not associated with any kind of leakages. Hence, the sole parameter for monitoring is the electricity generated by the project and supplied to the grid.

The Project is operated by WWIL and managed by the PP. The operational and maintenance contract for the project is with WWIL. WWIL follows the documentation practices to ensure the reliability and availability of the data for all the activities as required from the identification of the site, wind resource assessment, logistics, finance, construction, commissioning and operation of the wind power project.

### **Calculation of Net Electricity Supplied to the grid by project activity:**

Single Line diagram of Metering arrangement for project activity is shown in this section below.

The line diagram shown below refers to the entire project as a whole, thus it refers to the machines owned by both the parties VIPCPL & VREGPL. As there is no physical change in location, power evacuation systems, metering points etc, hence the same line diagram can be considered as applicable for the project after the ownership change as well.



\*Please refer to the Appendix 1 for more details on WTGs and also refer to Metering section below for more details on X1a and X1b.

From the line diagram (please refer below) it is clear that the machines of the project activity (i.e. 44 WEGs by VIPCPL and 19 WEGs by VREGPL) and other project developers at the wind farm have individual metering points at 33 kV at the project site. Further PP has made clusters of WEGs at the project site for the purpose of metering. Each cluster has a main meter. The WECs of the project activity are connected to individual dedicated cluster meters.

From the above layout it is clear that the clusters meters (i.e. dedicated meters/ individual meters attached to the WEGs w.r.t. HTSC nos.) of project activity and other customers are connected to the WWIL pooling sub-station at Pillayarkulam at bulk metering point at 110 kV. There is one main and one check meter at the WWIL substation. Since the main and check meters (bulk meter) at 110 kV metering point at the WWIL pooling substation is connected to the machines of the project activity and the machines commissioned by the other project developers, therefore in order to determine the net electricity supplied to the grid and/or third party at 110 kV at the WWIL substation, the state utility apply line loss to the meter reading recorded at the 33 kV. There is no any physical change to the WEGs and their power evacuation system post the ownership change.

The total % of Line loss from WEGs (33 kV metering point) to WWIL substation (110 kV metering point) is calculated by the state utility. Net Electricity supplied to the grid and/or third party by project activity is calculated by applying Line loss to the meter readings taken at 33 kV metering point of the project activity.

**The procedure for calculation of the percentage Line loss is set-out below:**

$$Z = ((X_1 + X_2 + X_3 + X_4 + \dots + X_n) - Y) / (X_1 + X_2 + X_3 + X_4 + \dots + X_n) \times 100\%$$

Where,

*Z = Percentage Line loss incurred in Line between the meters located at 33 kV metering point (including the machines of the project activity and other project developers) and the meters located at 110kV metering point (bulk meter: main and check) at high voltage side of receiving sub-station. Refer above picture for schematic of the flow diagram.*

*(X<sub>1</sub> + X<sub>2</sub> + X<sub>3</sub> + X<sub>4</sub> + .....X<sub>n</sub>) = Summation of meter readings (Export- Import) at 33 kV metering points for all the project developers connected to receiving substation (including the machines of the project activity and other project developers)*

*X<sub>n</sub> = Net Export (Export – Import) Reading (X<sub>i</sub>) noted at energy meter installed at 33kV metering point where i vary from 1 to n which represents the meters connected to project activity and other project developers. X<sub>1</sub>, X<sub>2</sub>, X<sub>3</sub>,...X<sub>n</sub> are the meters that are installed at 33kV metering point (including the machines of the project activity and other project developers) and further connected to the receiving substation at 110 kV by internally connected lines. Refer above picture for schematic of the flow diagram.*

As per prevailing practice at Tamil Nadu, there are dedicated metering systems for each WEG (for individual WEG or sometime for a group of WEGs) at generation end and bulk metering system available at receiving end based on which TNEB/TANGEDCO estimates net exports for each client and monthly generation statements are produced.

Here, X<sub>1</sub> is the representation of series of such dedicated meters (i.e. either individual or clusters) attached to the total 63 WEGs of the project. Erstwhile entire 63 WEGs were under the direct ownership of VIPCPL, hence X<sub>1</sub> represented as the cluster of dedicated meters attached to WEGs w.r.t. their HTSC nos. for VIPCPL. However, during post registration change, 19 WEGs were taken under the ownership of VREGPL; therefore this representation has been changed in terms of their line diagram interpretation; whereas physical status of the evacuation system, actual practice of metering and method of calculating net export to generate monthly statement etc. all remain the same. The 44WEGs of VIPCPL continues to supply electricity to TNEB for which the monthly statement for WEGs is issued separately as per the HTSC nos. of the machines. The 19 WEGs of VREGPL supplies power to the third party via wheeling for which monthly statements are also issued by TNEB/TANGEDCO separately as per the HTSC nos. of the machines. Thus, power

generation dedicated to both VIPCPL & VREGPL are still separately available as per the monthly generation statements issued by TNEB/TANGEDCO. The single line diagram has been modified as per the post registration changes and revised version (as included above) presents the current scenario.

*Y = Net Export (Export-Import) Reading at bulk meter installed at high voltage side of transformer of the receiving sub-station at 110 kV connecting machines of the project activity and other project developers. Refer above picture for schematic of the flow diagram.*

Therefore Line Loss for the project activity (between 33 kV & 110 kV metering point) is calculated as follows:-

**Line Loss ( $T_E$ )** = Percentage Line Loss \* Net Export recorded at 33 kV metering point of project activity

$$T_E = Z \times (EG_{\text{Export},y} - EG_{\text{Import},y})$$

Therefore Net Energy Supplied to Grid and/or third party (or net generation) after adjustment of Line loss is calculated as below:-

$$EG_{P,J,y} = EG_{\text{Export},y} - EG_{\text{Import},y} - T_E$$

The monthly statement showing the Energy Generated by the project activity as provided and duly signed by TNEB/Tirunelveli Electricity Distribution Circle, Tirunelveli) contains the following data:-

1. Electricity exported by project activity to grid recorded at 33 kV metering points (Cluster meter) ( $EG_{\text{Export},y}$ )
2. Electricity imported by project activity to grid recorded at 33kV metering point (Cluster meter) ( $EG_{\text{Import}}$ )
3. Line Loss ( $T_E$ ) between the metering point at 33 kV metering points of project activity and the metering point at 110 kV at the WWIL pooling substation
4. Net Electricity Exported to the grid by the project ( $EG_{\text{Export}} - EG_{\text{Import}} - T_E$ )

The cross checking mechanism for parameter  $EG_{BL,Y}$  net generation is prescribed under the data tables above. However, as per applied methodology ACM0002 the cross checking mechanism is stipulated only for the parameter " $EG_{BL,y}$ ". Therefore, no specific cross check mechanism is prescribed for export, import and line loss parameters.

The accuracy of monitoring parameter is ensured by adhering to the calibration and testing of the metering equipment once in five years. WWIL provides the daily generation report to the Project proponent. The project proponent also maintains the records of daily generation report and joint meter report.

Few more information are provided in the Appendix 1.

### **Training and maintenance:**

Training on the machine is an essential pre-requisite, to ensure necessary safety of man and machine. Further, in order to maximize the output from the WECs, it is extremely essential, that the engineers and technicians understand the machines and keep them in good health. In order to ensure, that WWIL's service staff is deft at handling technical snags on top of the turbine, the necessity of ensuring that they are capable of climbing the tower with absolute ease and comfort has been established. The WWIL Training Academy provides need-based training to meet the training requirements of WWIL projects. The training is contemporary, which results in imparting

focused knowledge leading to value addition to the attitude and skills of all trainees. This ultimately leads to creativity in problem solving.

### **Quality Control System:**

**Metering and Monitoring Plan details:** The general conditions set out for metering, recording, meter readings, meter inspections, Test & Checking and communication shall be applicable as per the PPA (Power purchase agreement) & Wheeling agreement with the State electricity board except or otherwise explicitly mentioned in the PDD.

**Metering Equipment:** Metering equipment is electronic trivector meter of 0.2s accuracy class.

**Metering:** The electricity supplied to the grid is metered from main meters that are connected to the 63 turbines of the project activity. The electricity export and import for the project activity is taken from the monthly joint meter readings noted from the dedicated meters (individual meters to WEGs or in some cases group of WEGs as can be identified from the allotted HTSC nos.) connecting 63 turbines of the project activity.

The project activity has clusters of WECs at the project site for metering. Each cluster (i.e. individual/dedicated meter either for individual WEG or for group of WEGs as per allotted HTSC nos.) will have one main meter. Summation of meter reading for all the clusters (connecting 63 total machines) will provide net electricity generated by the project activity after adjustment of transmission loss.

Currently, there are 44 WEGs under the ownership of VIPCPL wherein 40 WEGs have individual/dedicated meters and remain 4 WEGs have 2 group meters each with 2 WEGs. In case of 19 WEGs under the ownership of VREGPL, 11 WEGs have one dedicated cluster meter and remaining 8 WEGs have individual/dedicated meters. These metering arrangements (i.e. reference of the Individual and group/cluster meters) correspond to the different HTSC nos., as listed in the last table under the Annex 1 of the PDD. In the single line diagram, referred under the Section B.7.3, the individual/dedicated meters and group/cluster meters are represented as cluster meters "X1a" and "X1b" for VIPCPL and VREGPL, respectively.

**Meter Readings:** the parties (WWIL personals and personals of TNEB) take the monthly meter reading jointly for every month. At the conclusion of each meter reading an appointed representative of TNEB and WWIL sign a document indicating the number of Kilowatt-hours (kWh) indicated by the meter.

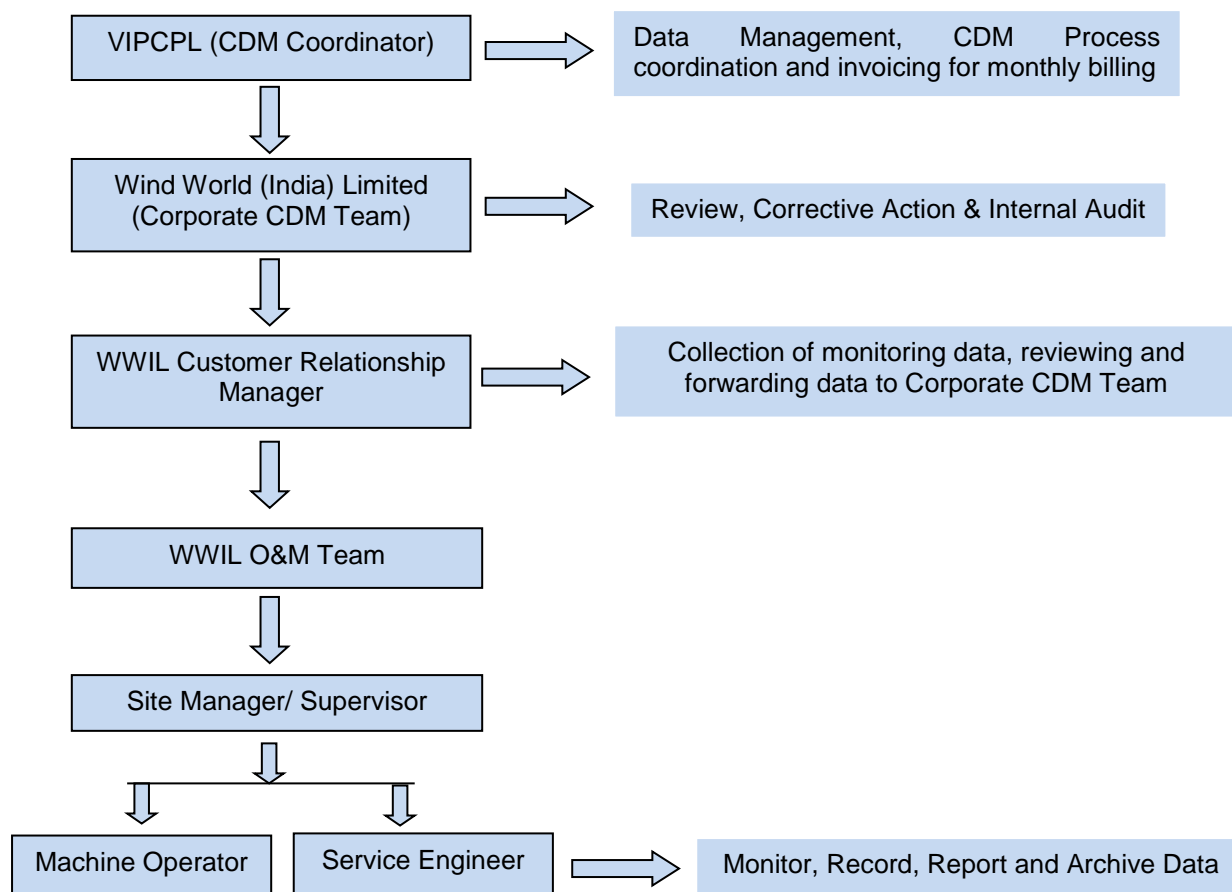
**QA/QC Procedure:** All the meters are calibrated/ tested once in five years. LCS meters do not require calibration as the energy readings of electricity generated at the LCS meter is cross verified by the energy calculated by inverting system installed in the WECs. In case there is any mismatch in the energy values recorded by the LCS meter and the energy values calculated by the inverting system; the machine will stop working and generate the error report. Further, the net electricity supplied to the grid that is used for calculation of emission reductions can be cross checked from the invoices raised by the PP on the state utility. Therefore, there is no data uncertainty. The calibration is done by the officials of the state utility. Copy of calibration/testing certificate will be kept as record by the PP and will be presented to the DoE during verification exercise.

**Main and Check meter:** In case the main meter(s) at 33 kV metering point (cluster meter) is found to operate outside the permissible limits, the main meter will be either replaced or calibrated immediately and for the period during which meter was faulty the LCS controller reading will be

referred to calculate electricity exported by WEGs. At 110kV metering point at WWIL pooling sub-station; in case the main meter(s) is found to operate outside the permissible limits, the main meter will be either replaced or calibrated immediately. Whenever a main meter goes defective, the consumption recorded by the Check meter will be referred.

PP is monitoring the data sent by the O&M contractor and the data for electricity generated by the project activity have been kept as records for the period of 10+2 years i.e. 2 years beyond the term of crediting period. WWIL is O&M contractor and responsible for data recording.

The operational and management structure implemented for data monitoring is as follows:



### **Metering system details:**

The details of meters installed at the site are provided below. It is to be noted that the earlier meters were replaced with new version of DLMS meters by authority during the period Jun-Nov 2017. The information on meter replacement along with other details are provided in the table below. This meter replacement activity falls within this current monitoring period and replacements were done within the validity period of the meter testing due dates. Thus, there is no delay experienced in the calibration frequency during this current monitoring period.
