
Letter of Approval for CGN Inner Mongolia Zhurihe Phase II Wind Farm

2. CGN Inner Mongolia Zhurihe Phase II Wind Farm Project complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. CGN Wind Power Co., Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. CGN Wind Power Co., Ltd. is permitted to transfer to Carbon Resource Management Ltd. which is authorized by the Government of the United Kingdom no more than 400,000tCO₂e in total Certified Emission Reductions (CERs).
