4. XinJiang A'letai Hua'ning Hydropower Investment Developing Co., Ltd is permitted to transfer to Carbon & Energy Capital Co. LTD and GFACC (IOM) Limited which are both authorized by the Government of the United Kingdom no more than 1,810,000tCO₂e in total Certified Emission Reductions (CERs).
