- (ii) M/s Janardan Wind Farm Pvt. Ltd. shall inform National CDM Authority regarding transaction details of CERs including the name and address of the party to which CERs were sold within 30 days of transfer of the CERs.
- (iii) M/s Janardan Wind Farm Pvt. Ltd. shall furnish expeditiously any information, during the lifetime of the project as requested by the National CDM Authority.
- (iv) M/s Janardan Wind Farm Pvt. Ltd. shall obtain all statutory clearances and other approvals as required from the competent authorities for setting up the project.
- (v) All transactions shall be subject to supervision of the Executive Board of the CDM, under the authority and guidance of the COP/MOP.
- (vi) This approval is not transferable. The authority reserve the right to revoke this Host Country Approval if the conditions stipulated in this approval are not complied with to the satisfaction of the National CDM Authority.
