Status report of the annual inventory of Monaco

Note by the secretariat

The status report of the annual inventory of Monaco was published on 7 June 2019. For purposes of rule 10, paragraph 2, of the Rules of procedure of the Compliance Committee (annex to decision 4/CMP.2, as amended by decisions 4/CMP.4 and 8/CMP.9), the report is considered received by the secretariat on the same date. This report, FCCC/ASR/2019/MCO, contained in the annex to this note, is being forwarded to the Compliance Committee in accordance with section VI, paragraph 3, of the annex to decision 27/CMP.1 and paragraph 49 of the annex to decision 22/CMP.1.



Status report of the annual inventory of Monaco

1. This status report was prepared by the secretariat pursuant to decision 22/CMP.1 in conjunction with decision 4/CMP.11, as part of the initial check of Monaco's 2019 annual greenhouse gas inventory, submitted in accordance with decisions 24/CP.19 and 15/CMP.1 in conjunction with decisions 3/CMP.11 and 2/CMP.8.

2. The report reflects the content of the inventory submission as submitted by the Party, which, in accordance with 24/CP.19, is due by 15 April each year (dates of submission are provided in the table on page 2).

3. In accordance with decision 24/CP.19 Parties report aggregate emissions and removals in carbon dioxide equivalent using the global warming potential values from the Fourth Assessment Report of the Intergovernmental Panel on Climate Change over a 100-year time horizon.
